2024 / 2025 SEASON for Trails End Homeowners Association.

The following positions for TEHOA Board are up for election this June 2024.

President:

Vice President:

The job descriptions as provided by the Bylaws are below:

President: The President is the Chief Executive of the Association, and as such, shall enforce all the provisions and purposes thereof.

- a) Preside at all meetings of the Association and of the Board of Directors
- b) Sign checks as required when supported by bills as presented by the Treasurer.
- c) Appoint or delegate the appointments of the members of all committees unless there is a motion requesting a special committee.
- d) Appoint these committees, as required: Legislative, Nominating, Grounds & Dock Maintenance, and Membership.
- e) Be an unofficial member of all but the Nominating Committee.
- f) Perform such other duties as pertain to this office.
- g) Review security footage of TEHOA properties as needed with another member of the BOD.

Vice-President. The Vice President in the absence of the President shall perform the duties of that office and shall discharge such other duties as may be required.

The officers and directors shall be elected at the annual meeting of the Trails End Homeowners Association, Inc. and shall hold their office for a period of two (2) years. To be eligible to be an officer or director, a candidate must be a homeowner or lot owner, a current paid member of the Trails End Homeowners Association at the time of their election and throughout their term of office. There may be only one board member per household. Any officer may be re-elected for the same office or any other office; however, no director shall serve more than three (3) consecutive elected terms. Board members are required to sign the Code of Ethics Addendum to Bylaws.
